## **FEE RULES**

- The Academic Session is from April to March.
- Annual Fee may be paid in two instalments due in April & October.
- School Fee is payable before 10<sup>th</sup> of each month.
- Late Fee : The following penalties will be levied in case the fee is not paid within stipulated time:
  - (a) Rs. 20/- per day if the fee is paid between 11<sup>th</sup> and 20<sup>th</sup> of the payable month.
  - (b) Rs. 100/- per day if paid between 20<sup>th</sup> and the end of the payable month.
  - (c) Beyond the above date, re-enrolment of the child will be done (subject to discretion of the school authorities) and fee will be charged accordingly.
- Any amount paid (Except Security Deposit) will not be refunded either in full or part, on any account whatsoever.
- No deduction of Fee is to be made for a period of absence or holidays.
- Those seeking admission in mid-session are liable to pay fee from the beginning of the session.
- In case of the last date of fee submission being a holiday, the fee may be paid on the next working day WITHOUT ANY FINE.
- One calendar months notice is required before the child is withdrawn from the school or one month's fee is to be paid in lieu of the notice. Same rule is applicable for discontinuing the transport facility.
- The school fee is subject to revision from time to time according to the State Govt. Directives.
